DEFINITIONS

Throughout this Manual, the under-listed words and expressions shall have the meanings attached to them:

- 1. 'University' shall mean University of Education, Winneba (UEW).
- 2. 'Management Board (MB)' shall mean the Board of Trustees set up by the University to manage the Fund.
- **3. 'Council'** shall mean the Governing Council of the University established under University of Education, Winneba, Act 2004, (Act 672).
- 4. 'Manual' shall mean the Operational Manual.
- **5. 'Beneficiary', 'Beneficiaries'** shall both mean those persons or departments qualified to be paid money out of the Fund.

1.0 INTRODUCTION

The Research, Innovation and Staff Development Fund (RISDF) of University of Education, Winneba is part of the University's effort at improving research culture in the University. It is a tool designed to enhance and create an enabling environment for increased growth in cutting-edge research as well as groundbreaking research in the long run.

The establishment of this Fund is a strategy to overcome the University's challenge of limited research facilities and financial resources for research. It is borne out of the recognition for the need to strive and create an enabling environment for research by investing heavily and rapidly in human capital development and high-end research facilities. It shall provide funding for staff development, research facilities and actual research with the aim of encouraging staff to conduct research. This will contribute to enhancing the academic and research profile of staff and ultimately the ranking of the University. It will also create the forum for the University to exhibit its research and innovative activities and achievements to the public and the world.

Through enhanced research and scholarship, the University can better impact national policies, especially those on education. Intensified scientific and scholarly research activities will bring about innovations and inventions that could contribute to the transformation of the National Economy. The Fund will support locally relevant research in the areas of education, sanitation, health care,

language, science, technology, vocations and agriculture to bring about groundbreaking findings to reduce poverty and help solve other pertinent developmental problems in Ghana. Generally, research leads to innovation, technology development and technology transfer through the identification and nurturing of early stage ideas, prototypes, start-ups, innovations, and technologies. It then transfers these early stage ideas, prototypes, start-ups, innovations, and technologies into new products, commercial ventures and industry for socioeconomic development and transformation of society.

Expanded research activities will, in the long run, enhance and promote teaching, learning, further research and extension services to the community and make the University more visible and relevant to the Ghanaian society and the world. Through this, the University can quite quickly achieve its Vision of becoming a leading University recognised worldwide for excellent academic and research activities in teacher education and policy.

The Fund will specifically cover the following:

- i. Providing research grants to staff
- ii. Providing conference grants to staff
- iii. Providing faculty development grants for doctoral, post-doctoral and other fellowships and
- iv. Funding research capacity building of staff

The Fund will be managed on the basis of well-publicised calls for proposals open to all senior members of the University. Approved proposals will result in Performance Agreements between the RISDF Management Board and the Faculty/School. In addition, it will support conferences and staff development on the recommendation of the relevant University Officer or Committee or Board (for example, Conferences and Scholarship Committee or Vice-Chancellor). Funding will also be made available to build staff capacity in the areas of research management to provide human resource and leadership to support research, especially in the following areas:

- Costing and pricing of research projects/activities;
- ii. Contract management;
- iii. Project/logistics management;
- iv. Procurement/contracting;
- v. Research administration:
- vi. Fund raising; as well as mechanisms, strategies, systems and processes to ensure the availability of funds for research;
- vii. Management of research funds;
- viii. Grants management software;
- ix. Monitoring and evaluation of research projects, and
- x. Research management services.

RISDF will be financed with contributions from internally generated revenue/funds (IGF) approved by the Governing Council and support from individuals, partners, and organisations interested in research, technology transfer and national development.

1.1 Characteristics of RISDF

The current financial planning, resource allocation and funding methodologies in the University are generally based on the number of students in each department and other variables such as the number of courses and type of programme. Research output is not a key variable in this resource allocation model. These funding methodologies are the same in other public universities in Ghana and many other countries.

This Fund will allocate resources to research using a methodology designed to encourage excellence in the generation of new knowledge through a competitive application process. In addition, a "performance agreement" which establishes agreed performance indicators are put in place and funds are disbursed as these defined milestones or indicators are achieved. Another unique characteristic of the Fund is its dependence on Deans and Heads of Department. The Deans and Heads of Division/Institutes/Department are highly involved in the supervision of the research activities in their respective faculties/schools and Departments. Heads of Department are part of the signatories in the Performance Agreement, while Deans are signatories to the bank accounts into which the funds for each research activity are deposited.

By research, we refer to "a wide range of systematic activities broadly designed to generate primary and/or secondary empirical data" to inform policy and practice and as a global public good. Innovation in this manual is defined as a "new and different way of doing things that brings about improvement".

2.0 OBJECTIVES OF THE FUND

The principal purpose and intent for which the Fund is established is to provide a system for funding, administration, management, investment and disbursement of resources for research, innovation and staff development.

2.1 General Objectives

UEW-RISDF is designed to address the following general objectives:

- To create an opportunity for staff of the University to access funds for research.
- To create an enabling environment in the University for research and creative works.
- iii. To promote and advance outstanding scholarship,
- iv. To promote increased research activities in the University,
- v. To enhance the academic profile of faculty,
- vi. To improve the ranking and visibility of the University through research,
- vii. To raise the quality of teaching and learning activities in the University,
- viii. To raise the quality of community service provided by the University,
- To enhance research management and administration in the University, and
- To develop the teaching and research capacity of staff for contributing to the development and transformation of Ghana.

2.2 Specific Objectives

RISDF has four specific objectives that will be pursued through the various funding mechanisms within the framework of its general objectives. These are:

2.2.1 To provide funding and other resources for staff research activities and to manage their outputs and outcomes

- The Fund will support research proposals that are recommended by the Proposal Review Committee. These proposals can be in any of these four categories:
- i. Starter grant proposals: These are very small and exploratory research proposals with budget of up to GHS5,000.00 and maximum duration of 12 months. It is meant for staff at the early stages of their career or profession, for example, Senior Members of the rank of Assistant Lecturer and Lecturer and their equivalents. This type of grant is meant to support staff to grow and to explore bigger ideas for bigger grants in the future. It is also available for Ph.D students at the final stages of their studies with the direct support of their supervisors and departments.
- ii. Small grant proposals: These are small research proposals with

budget of up to GHS10,000.00 and a maximum duration of 24 months. It is meant for middle level staff, for example, Senior Members not below the rank of a Senior Lecturer or its equivalent.

- iii. Medium grant proposals: These are medium and multi-disciplinary research proposals with budget of up to GHS50,000.00 and maximum duration of 36 months. These grants are open to Senior Members not below the rank of a Senior Lecturer or its equivalent.
- iv. Large grant proposals: These are large scale, multi-disciplinary, inter-faculty and inter-university research proposal with the potential to influence national policy and address national developmental and transformational needs. These are proposals with budgets of up to GHS100,000.00 and a maximum duration of 60 months. These grants are open to Senior Members not below the rank of a Senior Lecturer or its equivalent.
- The Fund will enhance the physical research environment (for example, improved laboratory facilities and equipment, up-to-date books and journals, and better access to technology).
- The Fund will support and promote the exhibition and publicity of research activities and research achievements of the University to the world.

The Fund will support monitoring and evaluation of research activities and research projects in the University.

2.2.2 To provide funding and other resources for staff conferences and training

- The Fund will encourage and support staff to present and publish their research findings at national and international knowledge sharing and networking events such as workshops, seminars/conferences and training programmes. Attendance at these forums by both young and experienced researchers will particularly be encouraged and supported. The approved recommendations of the Conferences and Scholarship Committee are relevant here.
- The Fund will also support departments, faculties/schools and subject groupings to organise local and international conferences, meetings and workshops.

2.2.3 To provide funding for faculty development in the areas of doctoral, post-doctoral and other fellowships

To give meaning to the University's drive to ensure that all faculty members have Ph. D or other terminal qualifications as the basic qualification for lecturing, the Fund will support faculty members to pursue Ph. D and other terminal qualification programmes.



- The approved recommendations of the Conferences and Scholarship Committee are relevant here.
- and other fellowships. This will be for staff who have just completed doctoral studies to improve their understating of a specialised area or subject and by so doing infuse and imbibe them with unique and demand-driven skills. Post-doctoral fellowships will offer staff opportunities to be engaged in a structured period of mentored research and or scholarly training with the aim of acquiring the needed professional skills and dexterity to pursue their chosen career.

2.2.4 To provide funding for research capacity building of staff

- The Fund will encourage and finance capacity building programmes in the areas that directly support research. These training and capacity building proposals can be in any of these five categories:
- Research and grant management services
- ii. University and research governance
- iii. University and research management and administration
- iv. Research skills and capacity
- v. Specialised skill building or training sessions in these specific areas: entrepreneurship, technology transfer, proposal writing, fund raising, intellectual property, patents, copyright, inventions and innovations

3.0 MANAGEMENT OF THE FUND

3.1 The Management Board

The Fund shall be under the Control of the University Council through its Finance Committee and be administered by the Finance Officer under a Management Board (hereinafter referred to as the Board of Trustees) made up as follows:

- i. The Vice-Chancellor as Chairman
- ii. The Pro-Vice-Chancellor

- iii. The Registrar as Secretary
- iv. Finance Officer as Administrator
- v. A representative of the Academic Board
- vi. The Dean of Graduate School
- vii. The Director of University Research Centre (Co-opted Member)
- viii. The University Treasury Officer

3.1.1 Functions of the Management Board (MB)

The primary responsibility of this Board is to ensure the resources of the Fund are managed in accordance with established and relevant rules, regulations guidelines and laws and that the proposals approved will promote the University's overall goal for setting up the Fund. It will discharge this responsibility through the specific functions indicated below.

- i. On an annual basis, the MB will recommend to the Finance Committee of Council, for approval, the total income accruing to the Fund and the proposed allocations for the four main funding categories of the Fund and the total amount that the RISDF shall be disbursing in the year.
- ii. Announce calls for proposals at least two times in the year.
- iii. Approve proposals for funding based on the recommendations of the PRC
- iv. Receive and rule on any appeal by a proposal originator against the PRC
- Conduct an assessment of the impact of the Fund at least once every five years.
- vi. Prepare and present to Council an annual report on the Fund.
- vii. Undertake any other activities as requested by Finance Committee or Council.

3.2 The Fund Administrator

The Finance Officer shall administer the

Fund in accordance with this Manual and the Financial and Stores Regulations and under the direction and authority of the MB.

Functions of the Fund Administrator

- Prepare annual budgets of the Fund and implement them as intended.
- ii. Call for and receive all monies due the Fund and pay into the Fund bank account(s)
- iii. Keep proper books of account on all activities of the Fund
- iv. Disburse funds from the Fund to approved beneficiaries
- Maintain bank account(s) of the Fund and prepare periodic bank reconciliation statements
- vi. Keep all other records of the Fund
- vii. Prepare and present to MB an annual report on the Fund. At the minimum, this report shall cover the following:
 - Highlight of major research activities and research achievements of the University
 - Highlight major research challenges to be addressed in the coming years
 - Major thematic research areas which may require commissioned works
 - Grants disbursed by call and by category: current and cumulative
 - University's research fund raising activities, achievements and capabilities
 - Amount of other research grants won by the University: current and



- cumulative
- Detailed reports on each individual research project (completed and on-going)
- Financial report on the University's research activities and the Fund.
- viii. Coordinate all activities of the Fund
- ix. Perform any other duties that the MB may assign.

3.3 PROPOSAL REVIEW COMMITTEE (PRC)

The PRC is a quality control committee. The Committee is responsible for assessing and reviewing the research proposals brought before it to ensure that the proposals meet the required academic standard. This Five-Member Committee of experts, to be constituted by the Vice-Chancellor, would have membership from different disciplinary areas. The members should have strong academic reputation and should not be eligible to submit to the PRC a proposal for a grant from the Fund during the tenure of their membership. If a member of the PRC wants to apply for a grant from the Fund, he/she must submit his/ her proposal to the Vice-Chancellor who will constitute an independent panel of members from within and/or outside the University to review the proposal and forward their recommendation to the MB. A representative from the Registry shall serve as secretary while a representative from the Finance Section shall serve as a budget expert to the PRC.

The PRC shall be reconstituted each year. Every member of PRC can serve for as many times as the Vice-Chancellor may deem appropriate. In the performance of its work, the PRC may co-opt other experts or refer proposals to experts both inside and outside the University.

331 Functions of the PRC

- Review proposals submitted according to specific criteria established by the Management Board.
- Recommend proposals that meet the stated criteria to the Management Board for approval.
- iii. Return proposals deemed to have merit but not ready for approval to the originator(s) with recommendations for necessary actions and may be re-submitted.
- iv. Reject proposals deemed to be lacking in merit.
- v. Make recommendations to the Management Board on steps that may be necessary to improve the quality of proposals and the functioning of RISDF
- vi. To provide a written report to the Management Board of actions and activities they undertake
- vii. To undertake any other activities as requested by Management Board

3.3.2 Chairman of the Proposal Review Committee (PRC)

The Chairman of the PRC will:

Disseminate information on all RISDF

- activities to the University community.
- Publicise the results and achievements of RISDF activities to the University community.
- Support and assist awardees of RISDF grants to carry out their planned programmes, and facilitate the implementation of project activities within the University.
- Monitor and evaluate the progress of approved proposals under the RISDF, identify delays in implementation, and address the causes of such delays.
- Authorise release of milestone payments to awardees.

3.4 RISDF Coordinators

Each Head of Department shall serve as the RISDF Coordinator of his/her department. The RISDF Coordinator will be accountable to the head of the Faculty/School/Institute/ Division for the effective implementation of RISDF activities in the department. The RISDF Coordinator will perform the following functions:

- Publicise RISDF calls for proposals, inform potential applicants of guidelines and procedures, receive completed proposals from within the department, check them for completeness and compliance with guidelines, organise a departmental peer review, and forward them to the Proposal Review Committee for action.
- Promote, support and disseminate research and innovative activities within his/her department.

- Liaise with the MB with regard to project monitoring, financial administration, and management responsibilities.
- Liaise with the PRC to formulate strategies to enhance research quality in the department
- Support and assist awardees of RISDF grants to carry out their planned programmes, and facilitate the implementation of project activities within the department.
- Monitor and evaluate the progress of approved proposals under the RISDF, identify delays in implementation, and address the causes of such delays.
- Recommend for the approval of the Dean or divisional head, the release of milestone payments to awardees.
- Ensure that the eligibility requirements for the department's participation in RISDF are met and maintained.
- Host and coordinate all RISDF-related visits to his/her department.
- Submit annual report on RISDF and on all research activities in his/her department.
- Perform any other function that the MB may assign.

4.0 PROGRAMMES UNDER RISDF

There shall be six (6) categories of programmes under RISDF. Subject to the approval of Council, the MB may vary these categories as it deems appropriate.

4.1 Programmes and Allocations

RISDF will support innovative efforts to improve the quality, relevance, and efficiency of research and education. Financial support for research, innovative and staff development efforts are available through four general and two special programme categories of RISDF which are derived from the objectives of the Fund.

General Category: all departments with relevant activities are eligible:

- i. Research grants to staff
- ii. Conference and training grants to staff
- iii. Faculty development grants and
- iv. Research capacity building grants

Special Category: eligibility is determined by the MB according to specific departmental needs. No individual or department can apply for grants in this category:

- Research facilities, equipment and laboratories and
- ii. Others: Commissioned research works, project monitoring and evaluation, publicity, publication and general administration

In all cases, allocations will take account of Strategic/ Operational Plans of recipient departments.

RISDF Resources will be used to help eligible individuals and departments undertake innovative activities that seek to meet specific RISDF objectives.

Resources will be allocated to each of the six categories above on the following basis:

i.	Research grants to staff	40%
ii.	Conference and training grants to staff	20%
iii.	Faculty development grants	15%
iv.	Research capacity building grants	10%
V.	Research facilities, equipment and laboratories	10%
۷İ.	Others	5%

Total 100%

The Management Board (MB) may, with the approval of Finance Committee, amend the allocations above if they deem it necessary and in the interest of the University and the Fund. The total funds (actual amount) to be allocated in any year must, however, not exceed 75% of the total funds accruing to the Fund in the year.

5.0 SOURCES OF FUNDING

The Fund shall be financed through the following sources:

6.0 ELIGIBILITY CRITERIA

To be eligible to receive RISDF funding and benefits, individuals and departments will need to meet certain criteria. The proposed eligibility criteria are:

6.1 Research Grants

This is designed to promote collaborative and multi-disciplinary research. To qualify for a research grant, beneficiaries must meet the following requirements:

- Beneficiaries must form a team of between 3 to 5 members; at least 60% of the team members must be UEW staff and students.
- Except for starter grants, the team should be led by a Senior Member not below the rank of a Senior Lecturer or its equivalent in UEW

and must include at least one UEW Lecturer/Assistant Lecturer or their equivalents.

- 3. Team members must come from:
- At least two different departments in UEW for small grants
- At least one member must come from another disciplinary area or another University in Ghana for medium grants
- At least one member must come from another University outside Ghana for large Grants.
- A member of staff (Senior Lecturer and above) can lead a team only once in any year. However, staff can belong to as many teams as they wish.
- There must be an indication that research findings will be published in an approved journal (see appendix III for list of approved journals) or an indication that research findings will be presented at an approved conference.
- Approval of grant to team leaders after the second award will require evidence that, that team leader has attracted research funds of at least \$ 5,000.00 from outside UEW.

6.2 Conference and Training Grants

Staff must have their participation at a conference or training confirmed by the organisers and then apply to the Conferences and Scholarships Committee with all relevant documents and have their applications

recommended by this Committee to the Vice-Chancellor for approval.

Departments may also apply directly to the MB for funding to organise national or international conferences. A full proposal including draft programme, estimated cost, expected participants and estimated participation fee should be submitted to the MB at least six clear months to the event.

6.3 Faculty Development Grants

This is available for Teaching Staff only for the first five years of the Fund. Staff must have their applications for a Ph. D or any terminal qualification or post-doctoral or any other fellowship programme accepted by an accredited institution. They must then apply to the Conferences and Scholarships Committee with all relevant documents (including the total cost of the programme) and have their applications recommended by this Committee to the Vice-Chancellor for approval.

6.4 Research Capacity Building Grants

Departments may apply directly to the MB for funding to organise capacity building sessions in any of the approved disciplines. A full proposal including draft programme, estimated cost, expected participants, and expected outcome/impact, should be submitted to the MB at least three clear months to the event. The Division of Human Resource or the Centre for Continuing Education should be involved in any such proposal.

7.0 PROPOSAL GUIDELINES AND PROCEDURES

7.1 The Generation of Requests for Proposals

The BM will periodically (at least twice yearly) issue a public request for proposals in accordance with its annual work plan as approved by Council.

7.2 Standard Proposal Submission Form.

Standard Proposal Form will be employed by RISDF to ensure that comparative information is available on all proposals (see Appendix I for the Proposal Submission Form). The MB may amend the format for this form as and when necessary. The PRC or staff may make recommendations to the MB for the amendment of the form as and when necessary.

7.3 Proposal Submission Procedures and Deadlines

Deadlines for proposals submission will be defined by the MB, in consultation with the PRC, in its annual work programme. Proposals received by the MB/PRC after midnight of the deadline date will be deferred, for consideration, to the next funding cycle. Submission procedures and processes are outlined as follows:

A proposal is submitted on a standard form to the Department Coordinator prior to submission deadline.

- RISDF Department Coordinator registers the proposal, reviews it for completeness, makes copies, and forwards it to the PRC members one week prior to the date of their next meeting.
- PRC reviews each proposal for consistency with institution's strategic plan; assigns a priority ranking on this basis, and determines which proposals will be recommended and communicates this decision to the MB.
- Proposals recommended for funding by the PRC are forwarded to the MB.
- The MB meets to take decisions on the recommendations of PRC and other relevant committees and communicate to the PRC, Department Coordinators and proposal originators.
- The MB prepares Performance
 Agreement for signing by the ViceChancellor and Fund Administrator.
- The proposal originator signs the four original Performance Agreements, keeping one for him/ herself and distributing the other three.
- Upon receipt of the signed Performance Agreement, the Financial Officer arranges for the disbursement of funding for Milestone 1 to the host faculty in accordance with the approved funding schedule.

Upon receipt of this disbursement, the Faculty's Accountant informs the proposal originator and immediately pays this amount as per the proposal.

8.0 PROPOSAL REVIEW

8.1 Standard Review Criteria and Ratings

A list of proposed review criteria and score sheet for use by the PRC is provided together with possible associated ratings (see Appendix II for the proposal review form). Based on its ratings and overall qualitative assessment, a Review Panel will recommend one of the following:

- Recommended for approval without reservation;
- Returned for improvement and resubmission during the next call for proposals;
- c. Not recommended.

These criteria and ratings may be reviewed at the end of the funding cycle by MB to determine whether they may require modification or substitution. The PRC or staff may make recommendations to the MB for a review or amendment of the proposal review form and score sheet.

8.2 Proposal Feedback and Qualitative Comments from Reviewers

Each Reviewer will attach qualitative comments to each proposal reviewed for consideration by the proposal originator. Comments may discuss the relationship of the proposal to RISDF priorities, suggest a sharper focus on research, teaching/learning or management difficulties being addressed,

pose possible improvements in approach, urge a more effective organization or work, and/or recommend a more efficient use of budgetary resources. The purpose of the comments is to improve the quality of the ensuing proposal, or provide a basis for understanding a possible rejection of the proposal and what might need to be addressed in order to revise it for a possible re-submission.

8.3 Re-submission of Proposals

Proposals that have been returned for further development may be revised in response to PRC comments and re-submitted. Subject to satisfactory revision, such proposals may be re-submitted during the next call for proposals, to the relevant programme category.

8.4 Appeal of Proposal Assessment

If the originators of a proposal believe that their proposal has been assessed unfairly by the PRC, the originators may submit a written appeal to the MB. Upon receipt of a written appeal, the MB will select one of the following three courses of action: (a) refer the proposal in anonymous form to an independently convened sub-panel of three area specialists for a second opinion; (b) refer the appeal to the general meeting of MB for a decision; or (c) reject the appeal as materially unfounded. In all cases the decision of the MB shall be final.

13

9.0 ELIGIBLE AND NON-ELIGIBLE PROPOSAL EXPENDITURES

As explained in this Manual, research grant proposals should seek to achieve performance or output targets that represent a qualitative improvement in selected area(s). The various activities and inputs required to achieve these outputs will be reflected in the structure and content of the proposal's budget. Most proposed expenditures will be eligible for support by RISDF.

9.1 Eligible Expenses: Goods and Minor Civil Works

- instructional equipment
- research equipment of broad use (not for the exclusive use of one or two individuals)
- classroom furniture
- computers and computer accessories of broad instructional application
- textbooks
- scientific journals
- other instructional inputs
- the purchase of a mini-bus to transport students to field work may be considered (with strong justification)
- industrial attachments
- community placements (may also be permitted on an exceptional basis)
- Minor civil works (up to a value equivalent to GHS5,000) will be eligible only if they are required to

modify an existing building in order to accommodate new equipment (such as additional electrical wiring; security doors and bars).

9.2 Eligible Expenses: Professional development for academics, doctoral students and administrators

Various types of short and medium term training will be supported when justified by an approved proposal. These include:

- work attachments in other institutions not exceeding 12 weeks' duration;
- paid professional training courses not exceeding four (4) weeks' duration;
- academic staff exchanges of not more than one semester in duration;
- attendance at regular scheduled scientific meetings/fora when the participant will be presenting a paper;
- post-doctoral or sabbatical study programmes for serving Senior Members of an institution's academic staff of not more than 18 weeks' duration;
- up to 18 weeks in residence at another university in order to enable a doctoral candidate to undertake dissertation research; and
- distance education courses of all types.

9.3 Non-eligible Expenses

The following expenses will not be covered by financial awards from the Fund:

- vehicles:
- honorarium to project team members or UEW staff/student;
- civil works to construct a new facility; civil works to rehabilitate an existing facility in excess of GHS5,000;
- Full-time Ph.D studies in residence except for applications that come under the staff development category.

10.0 TERMS OF AWARDS OF GRANTS

10.1 Award Notification and Grant Contracting

Notification of the award will be made to the proposal originator in the form of a Performance Agreement that will define the terms of project financing and the originator's fiduciary and other project responsibilities.

Four original copies will be sent to the originator for signature by the originator and his/her Head of Department or relevant academic or administrative unit. When signed, the proposal originator shall retain one copy. A second copy will be provided to the Financial Officer. A third copy will be kept by the Head of Department. The fourth copy will be returned to the RISDE MB.

Following MB review of aggregate of proposal funding awards, a list of the approved proposals will be announced publicly and published on the University website.

10.2 Responsibilities for Contract Development, Awarding and Monitoring

Standard Performance Agreements developed by the MB is available (see appendix III for the initial Performance Agreements). The MB can modify the Performance Agreement as necessary to accommodate the specific circumstances of an approved proposal.

10.3 Performance Indicators

Drawing upon the content of an approved proposal, each proposal will contain two types of performance indicators:

- Performance milestones, used to measure implementation progress and to provide benchmarks for the release of project funds; and
- Performance outcome, used to measure the ultimate impact of project activities.

10.4 Amendments to Performance Agreements

Upon the receipt of a justifiable request from the proposal originator, the MB may amend the Performance Agreement to reflect a modified agreement. However, such amendments may not increase the amount of approved funding for the project.

10.5 Intellectual Property

Any intellectual property produced in the course of research or experimentation conducted under an approved RISDF proposal, whether these be products, techniques, or services, will belong to the University. The University may share or cede these benefits to third parties, including the proposal originator(s), in accordance with prevailing regulations approved by Council.

11.0 FINANCIAL MANAGEMENT, PROCUREMENT, PROJECT MONITORING, ANNUAL REPORTS, CURRENCY AND MEETINGS

11.1 Financial Management and Financial Reporting Requirements

The financial management and financial reporting requirements are described in the UEW Financial and Stores Regulations.

11.2 PROCUREMENT OF EQUIPMENT AND CONTRACTING OF MINOR CIVIL WORKS

All procurement under the project will be based on regulations contained in the Public Procurement Act 2003, Act 663 and the Procurement Manual.

11.3 PROJECT MONITORING

11.3.1 Responsibilities for Monitoring

The Chairman of the PRC will be responsible for verifying that performance milestones

included in performance agreements have been reached, and subsequently, inform the MB that the next payment of funds under this contract may be made. RISDF Officers appointed by the MB will periodically visit departments to assess progress, address problems, and review the achievement of performance milestones. In addition, once a year, teams comprising MB and PRC will collectively visit departments for an annual assessment of RISDF accomplishments. The report from these visits will constitute an important part of the RISDF annual progress report to be presented to the University Council.

11.3.2 Timing of Monitoring

Project monitoring by the Heads of Department in their respective departments will be continuous. PRC and MB monitoring will be once a year.

11.3.3 Monitoring Reports

A written report from the group monitoring teams will be submitted to the MB by October of each year so that it will be incorporated into the project's annual progress report.

11.3.4 CURRENCY

All payments into and from the Fund shall be in Ghana Cedis unless otherwise decided by the MB or Council.

11.4 ANNUAL REPORTS

11.4.1 Accounts

The MB shall:

- Cause proper accounts to be kept showing all moneys received and disbursements made on account of the Fund
- Cause to be prepared consecutive statements of account consisting of income and expenditure account relating to a period of not more than 12 months and of a balance sheet relating to the end of such period.
- Ensure that the accounts are audited annually by the University's External Auditors.

11.4.2 Bank Accounts

The MB shall maintain such bank account(s) for the Fund as they consider convenient and every sum received on account of the Fund shall be paid into the account. All cheques and orders for the payment of money from any such account shall be processed in

accordance with the University's Financial and Stores Regulations.

11.5 MFFTINGS

11.5.1 Ordinary Meetings

- The MB shall meet at such times and places as the Chairperson may determine for the conduct of its business but shall meet at least four (4) times in each academic year.
- ii. The Secretary shall give each member not less than seven days' written notice of an ordinary meeting and such notice shall be hand delivered or sent by post.

11.5.2 Special/Emergency Meetings

- The Chairperson or any two (2)
 members of the MB may at any time
 summon a special or emergency
 meeting for any cause which may
 seem to him or them sufficient.
- ii. The Secretary shall, upon receipt of a written notice, signed by the Chairperson or any other two members of the MB requesting a special meeting, give notice in writing to each member of the MB inviting him/her to the meeting, and specify the object of the meeting.

11.5.3 Proceedings at Meetings

 At all meetings of the MB, the Chairperson shall preside and in his/ her absence any member appointed by the Chairperson to act for him/

- her shall preside. The Chairperson or his/her appointed representative shall have both original and a casting vote.
- ii. The MB may co-opt a person or persons to attend and participate in any of the meetings, but such person(s) shall not be entitled to vote.

11.5.4 **Quorum**

The quorum at all meetings of the MB shall be the Chairperson or his/her appointed representative as per 11.6.3 (i) above, the Administrator and any other two members.

11.5.5 Power of Majority

Every matter relating to the Fund which is considered at a meeting of the MB shall be determined by the majority of members of the MB present and voting on the matter. The decision of the majority shall bind all members, including those with the minority view/position, and the acts of the majority in the execution of the Fund shall be valid as if they acted in such matter unanimously.

11.5.6 Minutes

The Secretary shall keep a minutes book showing the minutes of all proceedings or meetings of the Trustees.

12.0 AMENDMENT OF THIS OPERATIONAL MANUAL

This Operational Manual should be viewed as a "living" reference document that can and should be revised, modified or amended on the basis of experience acquired in the implementation of the RISDF. Subject to the approval of the Finance Committee, the MB may amend this Manual as and when it becomes necessary.

APPENDIX II - GUIDELINES FOR PROPOSAL REVIEWERS

GUIDELINES FOR REVIEWERS

All reviewers will be provided with a copy of the Operational Manual of **RISDF** and a Proposal Scoring Form. Reviewers are advised to familiarize themselves with the contents of these documents since these will assist them in their reviews and scoring.

Reviewers will judge proposals on the set of criteria listed below on a five-point scale for each category, where "5" is excellent (highest score); "4" – very good; "3" – acceptable; "2" – questionable; and "1" – unsatisfactory.

Details of the expectations in each criterion and corresponding grades for each category are given below. Reviewers are expected to be familiar with this schedule and refer to it in their scoring.

1. Academic Excellence:

- To what extent will the proposed project increase the quality of research, teaching and learning or management to international levels of excellence for the field?
- Do the proposal activities convey up-to-date knowledge or skills, or cutting edge by the standards of the field?
- Do the capabilities, academic

credentials, professional experience and productivity records of the individuals involved with the project indicate a team capable and likely to perform at a high level of academic quality?

Does the proposal demonstrate familiarity with scholarship in the field and identify gaps in the literature?

- e. undertakes grant awarding procedures to Party B which conform to the provisions and conditions in this Performance Agreement, UEW Financial and Stores Regulation, and the RISDF Operations Manual.
- 1.2. PARTY B, in its capacity as the sponsoring department for the approved *RISDF* project proposal:
 - accepts the grant awarded by PARTY A for PARTY C to carry out the project;
 - b. implements the project through the indicated project management team (PARTY C) and shall be responsible for providing to PARTY C, promptly as needed, the funds, mentoring, facilities, services and other resources required for the project and assuring sustainability of the project throughout the implementation of this Agreement.

- 1.3 PARTY C, in its capacity as originator and implementer of the approved **RISDF** project proposal:
 - a. implements the Sub-project with due diligence and efficiency, and in accordance with sound educational, scientific, technical, financial, and managerial standards and practices, aimed at achieving the objectives of *RISDF* within the strategic framework of the department and satisfactory to UEW; and is responsible for reporting on the project implementation to PARTY A as stipulated in this Agreement;
 - b. is responsible for providing to PARTY A the following Sections: Section 9 (Financial Plan), Section 12 (Implementation Plan), Section 10 (Procurement Plan), and Section 11 (Conference/Training Plan) acceptable to PARTY A. Such information provided by PARTY C will form an integral part of this Agreement. Any authorized modifications to these Forms will likewise form an integral part of this Agreement.

CLAUSE 2

TIME FRAME

2.1. This Agreement remains valid throughout the time specified in the Project Implementation Plan. The project will be

carried out within [......] months, as specified in the project proposal. The implementation time begins from the date of the signing of this Performance Agreement.

2.2. If the implementation of the project is delayed for any reason, PARTY C must inform PARTY A and PARTY B in writing the reasons for the delay, and if necessary request an extension of the time allowed for implementation. PARTY C should not exceed the time period specified above, unless so authorized in writing by PARTY A.

CLAUSE 3

RESPONSIBILITIES OF PARTY A

- 3.1. Evaluation of the project implementation performance of PARTY B and PARTY C will be made through reports required under Clause 4, which shall be quarterly in the case of financial reports and every six months in the case of progress reports. Such evaluation will be undertaken by PARTY A at the end of each phase of the project.
- 3.2. During the life of the project, PARTY A or its authorized representative may inspect at any time: goods under the project, and any relevant documents and records for purposes of monitoring project implementation or conducting financial or technical review.

3.3. PARTY A is responsible for providing the grant amount to PARTY B in accordance with this Performance Agreement and for fully complying with the provisions and conditions regulated in this Agreement.

CLAUSF 4

RESPONSIBILITIES OF PARTY B

- 4 1 PARTY B is responsible for maintaining adequate financial records and accounts which conform to the financial accounting and procurement procedures governing RISDF project implementation and to International Public Sector Accounting Standards as well as UEW Financial and Stores Regulation, international financial management standards and norms. PARTY B is responsible for maintaining adequate documentation, records and reports relating to the procurement of goods or services and employment of consultants and other relevant documents on the implementation of the project to enable PARTY A to acquire necessary information at any time, as required by PARTY A for purposes of monitoring implementation of the project.

- 5.1 PARTY C is responsible for the overall implementation and phasing of the project punctually in accordance with Section 12 (Implementation Plan) and following the procedures laid out in Section 9 (Financial Plan), Section 10 (Procurement Plan) and Section 11 (Conference/ Training Plan).
- 5.2 PARTY C is responsible for submitting to PARTY A and PARTY B the following reports:

- 7.5 The financial records relating to the funds referred to in Clause 7.4 above, and to the project income and expenditure accounts and book-keeping records described above, as well as the quarterly and annual financial reports described in Clause 4, may be subject to inspection by authorized independent auditors at any time, as required by PARTY A.
- 7.6 For the purposes of this Clause the following terms shall be used and applied in all cases including the settlement of disputes:
 - The term "eligible expenditure categories" means the categories set out below:
 - Instructional equipment;
 - ii. Research equipment:
 - iii. Classroom furniture;
 - iv. Computers and computer accessories:
 - v. scientific journals and textbooks;
 - vi. Equipment required for field work;
 - vii. Minor civil works to modify existing buildings;
 - viii. Consumable materials:
 - ix. Short- and medium-term training for the professional development of academics, doctoral students, and administrators;
 - x. International consultants and visiting scholars from overseas;

- xi. Local consultants;
- xii. Overseas conferences, fellowships and internships;
- xiii. Local fellowships and internships;
- xiv. Overseas study tours;
- xv. Local conferences/training;
- xvi. Institutional partnerships.
- b. The term "eligible expenditures" means expenditures in respect of the reasonable cost of goods and services required for the project and financed in accordance with the grant procedures of this Agreement with regard to the eligible Categories of the project; and
- c. The term "Performance Milestone Payment" means an amount stipulated in Section 9 (Financial Plan) that will be paid to PARTY B for use by PARTY C whenever specifically defined progress goals are achieved in the implementation of the project. This payment will be debited against the total grant payable under this agreement. It will be withdrawn from the Project Account maintained by PARTY A and deposited into an Account maintained by PARTY B pursuant to Clause 7.4 of this agreement.
- 7.7 After PARTY A has received evidence satisfactory to it that PARTY B's Account has been duly and correctly stated with the Dean's approval, disbursements to PARTY B shall be made as follows:

- (a) Milestone Payment 1 shall be made by the MB, as designated in Section 9, upon receipt of an original copy of this Performance Agreement that has been duly signed by all three parties. In effect, the signed Performance Agreement shall constitute the project's first request for payment.
- (b) Subsequent milestone payments will be made, in the amounts indicated, against the achievement of the implementation goals contained in Section 9 and recommendation of the chairman of the PRC.

A letter to the MB through the Chairman of the PRC, signed by PARTY B, attesting that the next consecutive performance milestone has been achieved by PARTY C, will constitute each successive request for payment under the project.

- 7.8 For each expenditure made by PARTY B out of its Account on behalf of PARTY C, PARTY B shall, at such time as PARTY A shall reasonably request, furnish to PARTY A such documents and other evidence showing that such payment was made exclusively for eligible expenditures.
- 7.9 For all expenditures from its Account, PARTY B shall:
 - Maintain or cause to be maintained records and accounts adequate to reflect such expenditures in accordance with sound accounting practices;
 - retain, until instructed otherwise by PARTY A, all records (contracts,

- orders, invoices, bills, receipts and other documents) evidencing such expenditures;
- c. enable PARTY A's representatives to examine such records.
- 7.10 Notwithstanding the provisions of Clause 7.8, PARTY A shall not be required to make further deposits into the Account maintained by PARTY B:
 - a. If PARTY B shall have failed to furnish to PARTY A, within the period of time specified in Clause 4 of this Performance Agreement, any of the reports required to be furnished to PARTY A pursuant to said Clause;
 - b. Thereafter, withdrawal from the Account maintained by PARTY A of the remaining un-withdrawn amount of the grant under this Performance Agreement allocated to the eligible Categories for the Account maintained by PARTY B. shall follow such procedures as PARTY A shall specify by notice to PARTY B. Such further withdrawals shall be made only after and to the extent that PARTY A shall have been satisfied that all such amounts remaining on deposit in the Account maintained by PARTY B as of the date of such notice will be utilised in making payments for eligible expenditures.

7.11

- (a) If PARTY A shall have determined at any time that any payment out of the Account maintained by PARTY B:
 - Was made for an expenditure or in an amount not eligible pursuant to Clause 7.4 and 7.6; or
 - ii. was not justified by the milestone completion evidence furnished to PARTY A by PARTY B.

PARTY B shall, promptly upon notice from PARTY A:

- Provide such additional evidence as PARTY A may request; or
- ii. deposit into the Account maintained by PARTY B (or, if PARTY A shall so request, refund to PARTY A) an amount equal to the amount of such payment or the portion thereof not so eligible or justified.

 Unless PARTY A shall otherwise agree, no further deposit by PARTY A into the Account maintained by PARTY B shall be made until PARTY B has provided such evidence or made such deposit or refund, as the case may be.
- (b) If PARTY A shall have determined at any time that any amount outstanding in the Account maintained by PARTY B will not be required to cover further payments for eligible

expenditures, PARTY B shall, promptly upon notice from PARTY A, refund to PARTY A such outstanding amount.

- (c) PARTY B may, upon notice to PARTY A, refund to PARTY A all or any portion of the funds on deposit in the Account maintained by PARTY B.
- (d) Refunds to PARTY A made pursuant to Clauses 7.11 (a), (b), and (c) shall be credited to the Account maintained by PARTY A. Their subsequent withdrawal or cancellation shall be determined by PARTY A.

CLAUSE 8

SUB-PROJECT ASSETS AND SERVICES

- 8.1 Goods and services purchased under this Performance Agreement shall be used exclusively for the purpose of carrying out the project.
- 8.2 All books and journals procured under the project must be registered in line with the coding system of the University's library for overall management purposes.
- 8.3 All goods and equipment purchased under this Performance Agreement shall become the joint property of PARTY A and B and shall be registered in assets register of PARTY B.

CLAUSE 9

SUSPENSION AND TERMINATION

- 9.1 This Performance Agreement may be suspended or terminated prior to completion in the following cases:
 - a. PARTY B fails to comply fully with the regulations governing RISDF implementation, the requirements of the Financial and Stores Regulation, or responsibilities assigned under this Agreement. PARTY A, based on the level of violation by PARTY B, shall give a written decision on suspension or termination of this Agreement before completion.
 - If delay in the RISDF project implementation of PARTY B is due to unforeseen factors such as natural disaster or climatic conditions, earthquakes, fires, war, or any unexpected situations beyond human capacity, and these situations are certified to be the direct reasons for the delay or obstacle to the implementation of the project and PARTY B has tried alternatives to overcome these situations, the provisions and conditions regulated in this Clause may not be applied provided that PARTY B should inform PARTY A in writing, at most fourteen (14) days after the occurrence of such events, of the reasons and the applied alternatives, and should inform

- PARTY A as soon as possible after the situation has returned to normal.
- 9. 2 Delay or failure in the implementation of this RISDF project due to mistakes, errors or negligence on the part of PARTY C will be taken into account in assessment of any future RISDF project proposals submitted by PARTY B.

CLAUSE 10

SETTLEMENT OF DISPUTES

- 10.1 Any dispute arising out of this Performance Agreement shall, if at all possible, be settled through consensus ensuring mutual benefits.
- 10.2 If the dispute cannot be resolved on the basis of consensus, the dispute shall be referred to arbitration/adjudication in accordance with the existing laws and regulations in the University and Ghana. The settlement decision shall be final and binding on all parties.
- 10.3 Any fees and other related charges incurred in settlement of disputes shall be borne by the losing party.

CLAUSE 11

OTHERS

- 11.1 The terms and conditions of this Performance Agreement may be reviewed at the request of either Party after the start of implementation of the RISDF project. Any modifications of the contents of this Performance Agreement must be agreed upon by all Parties and in writing.
- 11.2 Any regulations relating to the project implementation not covered by this Performance Agreement shall be followed by the two parties in accordance with existing regulations in the University.
- 11.3 This Performance Agreement comes into effect and will be considered valid and binding on all parties on the date of signing by all parties.

The following list has been generated to help researchers identify those titles which are consistent with the University's research performance targets, i.e. selected journals listed in the top three quartiles in Thomson Reuters (formerly ISI) *Web of Science* and those with a *Scopus* SNIP (Source Normalized Impact per Paper) of .500 or more. *Web of Science* (Thomson Reuters) and *Scopus* (Elsevier) are both citation indexes; Thomson Reuters publishes the *Social Sciences Citation Index*, a tool which has been measuring impact in journals since 1955. Elsevier has moved into citation indexing more recently (2004), and *Scopus* was chosen by the ARC as the citation data provider for the ERA.

The list below has been drawn from the top three quartiles of the following categories in the Web of Science *InCites Journal Citation Reports*, 2015: Education and Educational Research (224 titles), Education, Scientific Disciplines (37), Educational Psychology (55), Special Education (39), Sociology (142), Hospitality Leisure Sport and Tourism (43), Social Issues (41), Interdisciplinary Social Sciences (95), Ethnic Studies (15), Linguistics (171), and Cultural Studies (37). Selected titles were also included from Environmental Studies, History, History of Social Sciences, Information Science and Library Science, and Women's Studies. In addition, keywords, such as Music, Performing Arts and Computers were searched if there was not a clear category for such fields.

All journals in the *Scopus Title List* that were coded in whole or in part to Education, with a SNIP (2014) above .500, have been included.

The Management Board (MB) may add other titles, provided that they meet the above criteria. In adding to this list, the MB shall consult the University Librarian, College Principals, Deans, Heads of Department and other staff and do a reconciliation of titles in which staff have published.
